

**Minutes of the EELA General Assembly  
of Saturday 14 June 2014  
Krupnicza 35  
Krakow, Poland**

**1. Opening**

The Chairman Guy Castegnaro gave key figures regarding the EELA membership:

Number of EELA members as of 27 February 2014: 1284

Members joined in 2013: 121

Membership cancelled: 94

33 European countries represented in EELA

**2. Report of the Board 2013/2014**

The Chairman reports on the four Board meetings which took place on:

- 6 June 2013 in Antwerp
- 23 September 2013 in Warsaw
- 31 March 2014 in Francfort
- 12 June 2014 in Krakow

The following achievements have been outlined:

- Cooperation with ERA (Academy of European Law):  
The Conference in Brussels in November 2013, organised in cooperation with ERA was a success. The EU Commission participated in the Conference, providing a highlight of future EU labour law developments
  
- Cooperation with ELLN (Employment and Labour Law Network)  
ELLN is an association of Academics in Europe, chaired by Pr Vaas and cooperates with the EU Commission. The relationships that ELLA and ELLN have established in 2013 will continue, through some invitations to their own conferences.
  
- Communication with EELA members and social Networks  
Regular communication has been established with EELA members between the annual conferences through newsflashes. The Linked In account is now up and running, to allow easy discussions between EELA members.
  
- Cooperation with SDU (EELC magazine)  
SDU will include news about EELA conference in the magazine, which is accessible to all members, and to improve the search function, to facilitate the search of case reports. The EELA members are encouraged to contact EELC national correspondents should they wish to publish case reports in the magazine or comments on other jurisdictions' case reports.

### **3. Update on future activities**

The Chairman announces that the new yearly EELA conference will be organised in Brussels on 28 November 2014, in cooperation with ERA. The conference will notably focus on European employment law subjects.

Cooperation between EELA and national employment law associations has been established, with a second meeting at the Krakow conference.

Further improvements of the website have been decided, now allowing members to post news in national rubrics, and allowing better access to EELC archives.

**4. Approval of the accounts.**

**The accounts** of the association are explained. The General Assembly approves the accounts unanimously.

**5. Any other issues - Closing**

Guy Castegnaro thanks the Belgian board member Bartlomiej Raczkowski for the very well organised Krakow conference and the exceptional presence of President Lech Walesa, which was highly appreciated.

It is announced that the next conferences shall be in 2015 in Cyprus.

George Georgiou warmly invites everyone to the 2015 conference to be held on 5 and 6 June 2014 in Limassol.

As no other business is raised, Guy Castegnaro closes the General Assembly.
